  - viii. Jamie will get posters out as soon as possible
- a. Manager Jamie report included items from business arising from previous meeting. The ammonia alarm still has to be installed by Woodhill. He has requested Keith's come to check all PSV valves. They are also to install the fire box to cover the release valve. He will contact Clint at Kneeland Construction to see if they are planning on repairing the self-closing garage door. There are also some minor repairs in the back room that Jamie and Joe will deal with. ABSA will be out to do a re-inspection prior to us opening. Motion to approve by Justin Paulgaard. Carried
- b. Lounge –Suzanne McCrea and Faye Mielke will be running the concession/lounge this year. They have agreed to run it on league nights but not come in prior to the curling times. People will be able to have a drink on the honor system before curling. The seniors have requested they be able to have a drink after the afternoon leagues. Joe has agreed to look after this. It will be cash only (\$5 a drink) and Joe will take the cash home and give it to the ladies. A lock will be put on the back room. All liquor will be purchased from Judes Liquor Store this year. Vicki, Gail, Suzanne and Faye will go over the contract and revise it. Motion to approve by Vicki Walstrom, Carried
- c. Off Season Rentals We have less rentals for this year. ID Apparel has opted to go somewhere else as we could not accommodate the dates they required. We will try to deal with this conflict prior to next fall. We will try to market these rentals better as a good venue. Nothing came back from the car dealerships. Steel Wheels were interested in renting for their caberat but through a discussion it was decided we are not a suitable venue for that. Vicki will contact them regarding this. - d. Social Media Vicki has done an amazing job with both websites. Steve asked everyone to go to our website and like and share. This will then take you to the Scotties website and please share it.
- e. Casino Our date is April 2019
- f. Raffle Heather has applied for the raffle license and will be in charge of our Raffle again. It will be drawn at our closing bonspiel. Two Hundred Fifty books of 10 tickets at a cost of \$2 per ticket will be printed. The prizes will be \$1,000 First Prize, \$300 Second Prize and \$200 Third Prize. All proceeds will be spent on maintaining the Stettler Curling Club Building. Kathy's Printing will print the tickets.
- g. Provincial Championship This event will be discussed in detail at the September 24<sup>th</sup> meeting. Steve has been extremely busy with this event. He will have a meeting with Sportsnet tomorrow. The \$6000 hosting fee has been waived. Curling Alberta will be donating \$2000 towards the banquet costs. A proposal has gone into Curling Alberta to pay for the umpire fees. More expenses will be discussed with Curling Alberta as the costs are adding up quickly. As Steve is now a board member of Curling Alberta he will have the chance to discuss this further. Steve also applied for 2 grants, one for \$55,000 through CIP and another for hosting a major sporting event.

## h. New Business:

- a. Board Members Justin gave his resignation to the board as he will be moving away. He will be greatly missed. We thanked him for all his help on the board. We will be short 2 board members (could use more) so information has gone out on this through Facebook. We will also be looking for a vice-president as Steve has indicated he will be leaving the board next year.
- b. 5 rock rule Curling Canada recommends that all leagues begin with the 5 rock rule this year.
- c. Concussion protocol. Steve proposed we adopt the new Concussion Guidelines and Return to Play policy for our curling rink. Curling Canada will be putting this policy into effect. I have attached a copy of this policy. Maureen Mailer made the motion to accept this policy. Carried
